



PLAYGROUND RULES

Violation of the Rules will result in temporary or permanent revocation of Your privilege to use the Facility property and facilities without a refund of any membership fee you may have paid

The Franklin County Sheriff's Department is authorized to police this property.
If you see illegal activity, call the Sheriff at (919) 496.2186.

1. The playground is on private property. Only members in good standing and their registered guests may enter onto any part of the property, which includes the parking lot, clubhouse, fitness room, pool, playground, and any other recreation element ("Facility").
2. **WAIVER OF CLAIMS.** By entering onto the Facility's property, you and your household members and guests agree that the Facility owner and management will not be responsible, liable, or otherwise accountable for any infection of any person with any bacteria or virus no matter the cause nor for any injury, loss, harm, damage, or other consequence of your presence on the property. **Everyone uses the Facility at her or his own risk.**
3. **No person having any of the symptoms of any communicable disease may enter upon the Facility property.** Any person exhibiting symptoms of a communicable disease may be asked by Facility staff to leave the Facility. Refusal to leave the Facility when requested by a Facility staff person will result in immediate and permanent termination of the refusing person's household's privilege to be on the Facility Property. No member has authority to request any other person to leave the Facility.
4. No person with open wounds, sores, skin infections, bandages, or band-aids is permitted inside the pool fence, fitness room, or playground fence.
5. The playground is only for the use of Members who are in good standing, and by their registered household members and registered guests. Anyone else is trespassing and should be reported.
6. Each person entering or inside the playground area must present photo identification upon request by a Facility staff person. Members also must present their access card. **All persons in the playground area must wear a wristband or other identifying device required by the Facility.** The access card and wristbands are property of the Facility. Discourtesy to the Facility staff is a violation of these Rules.
7. Member wristbands may not be loaned, gifted, sold, traded, bartered, or otherwise exchanged. Member wristbands may be used **ONLY** by full-time occupants of the member household. Part-time occupants, visitors, guests, friends, relatives, and the like **MUST** wear a guest wristband.
8. The playground has no rest room facilities.
9. **USE BY PERSONS OVER AGE 12.** No person over the age of 12 may use the playground equipment.
10. A Member is responsible for all conduct of his / her household members and guests and must accompany guests at all times. The Facility Guest Policy is a part of these Rules.
11. **Children under 12 years of age** must be supervised by an adult (a person over the age of 18) from the Member's household, another Member's household, or a registered caregiver at all times.
12. **Use the playground at your own risk.** The playset, swings, and surrounding areas are inherently dangerous with the risk of falls, collisions between users, and other hazards.
13. **NO GLASS IS ALLOWED IN THE PLAYGROUND AREA.** Broken glass in the playground will result in closure of the playground area for an indefinite period. The cost of removing broken glass will be assessed to the resident in violation of this rule. The membership of any member bringing glass into the playground area will be terminated permanently.
14. The playground may be closed at any time due to a mechanical malfunction, weather conditions, or any other reason to protect the property or your health or safety.
15. **No food or beverage (other than water in a plastic container) is allowed in or within 3 feet of the playset.**

16. No pets or firearms or other weapons on Facility property.
17. **No running anywhere inside the playground area.** Anyone running WILL BE asked to leave the playground area.
18. No profanity or other behavior that is offensive or inappropriate in the presence of children.
19. Audio and video may be played only through personal listening devices (earphones, headphones, and the like).
20. Everyone must leave the fenced-in playground area when thunder has been and must remain outside the playground area for 30 minutes afterward.
21. Securely close the entrance gate after passing through it. The gate never may be left open. **Do not allow any person not in your group to enter through the gate behind you, and do not open the gate for anyone.**
22. All persons entering the playground area must wear shoes and a shirt and appropriate lower body clothing.
23. Everyone must place their trash in the appropriate trash containers.
24. No bicycles, skates, heelys, skateboards, or scooters are allowed on Facility property.
- 25. No ball play inside the playground fence.**
26. No pets on Facility property, except in closed vehicles temporarily present to retrieve mail or pickup or discharge passengers.
27. No cooking or food preparation of any kind inside the playground area.
28. No chairs, lounges, tables, or umbrellas, except portable folding camping chairs in the playground area, except those provided by the Facility.
29. No smoking or vaping **anywhere** on Facility property.
30. No person using or under the influence of alcohol (above the legal limit for driving a car) or drugs is allowed on the Facility property. Illegal conduct will be reported to the Sheriff. Intoxication (above the legal limit for driving a car) is a violation of these Rules and WILL result in termination of membership.
31. No diving, flips, or other tricks or acrobatics.
32. Parking on the Facility property is for members and their authorized guests only. Overnight parking is not permitted. Vehicles violating the parking rules will be towed or disabled. The fee to remove a disabling device starts at \$500. Disabling devices will be removed at the convenience of the Facility staff.
33. These rules may change at any time without notice.
34. Please report any violation of these rules to Facility staff or using our website.
35. Violation of these Rules will result in suspension or termination of a household's membership in the sole discretion of the Facility.
