



FACILITY, POOL, AND FITNESS RULES

Violation of the Rules will result in temporary or permanent revocation of Your privilege to use the pool and Facility without a refund of any membership fee you may have paid

The Franklin County Sheriff's Department is authorized to police this property.
If you see trespassing, vandalism or other illegal activity, call the Sheriff at (919) 496.2186.

1. The pool is on private property. Only members in good standing and their registered guests may enter onto any part of the property, which includes the parking lot, clubhouse, fitness room, pool, playground, and any other recreation element ("Facility").
2. **WAIVER OF CLAIMS.** By entering onto the Facility's property, you and your household members and guests agree that the Facility owner and management will not be responsible, liable, or otherwise accountable for any infection of any person with any bacteria or virus no matter the cause nor for any injury, loss, harm, damage, or other consequence of your presence on the property. **Everyone uses the Facility at her or his own risk.**
3. The Facility is only for the use of Members, who are in good standing, and by their registered household members and registered guests. Anyone else is trespassing and should be reported. Tenants of a property are not members or guests.
4. Each person on Facility property must present photo identification upon request by a Facility staff person. Members also must present their access card. **All persons in the pool area must WEAR a wristband or other identifying device required by the Facility management.** The access card and wristbands are property of the Facility.
5. Discourtesy to the Facility staff is a violation of these Rules.
6. Member wristbands may not be loaned, gifted, sold, traded, bartered, or otherwise exchanged. Member wristbands may be used ONLY by full-time occupants of the member household. Part-time occupants, visitors, guests, friends, relatives, and the like MUST wear a guest wristband.
7. Each person **using the bathroom** must restore the bathroom to the condition in which she or he found the bathroom to ensure that sanitary conditions are maintained as well as possible between bathroom cleanings. The bathrooms are cleaned daily by the pool management company and deep cleaned weekly, but cleaning by Facility staff between use by members or guests and their children is not possible.
8. **BATHROOM USE BY MINORS UNDER AGE 12.** No person under the age of 12 may use the bathroom without the presence of a chaperone over the age of 16 either in the bathroom or immediately outside the bathroom (in the case of mixed gender minor and chaperone). The chaperone is responsible to ensure that the minor leaves the bathroom in the same condition as she or he found it and uses soap and water or sanitizer on his or her hands before leaving the bathroom. The bathroom hallway may be observed and entry into the hallway and restrooms may be recorded by video. No loitering in the restrooms or hallway. (No recording or observation is made of private areas of the bathrooms.)
9. A Member is responsible for all conduct of his / her household members and guests and **must accompany guests at all times.** The Facility Guest Policy is a part of these Rules.
10. **Children under 16 years of age** must be supervised by an adult from the Member's household, another Member's household, or a registered caregiver at all times. Each adult from the Member's household may supervise **no more than four (4) children** under the age of 16. Adult guests may supervise only their own children.
11. **No Lifeguards.** No lifeguards are at the Facility at any time. Any Facility staff person is not a lifeguard.
12. **BY LAW, NO GLASS IS ALLOWED IN THE POOL AREA.** Broken glass in the pool will result in draining, cleaning, and refilling the pool and Health Department inspection, potentially closing the pool indefinitely. The cost of this will be assessed to the resident in violation of this rule. The household membership of any member bringing glass into the pool area will be terminated permanently.
13. The pool may be closed at any time due to a mechanical malfunction, weather conditions, or any other reason to protect the property or your health or safety. No refunds are given for pool closure.

POOL HOURS

From season opening in May to closing in September

8:00am to SUNSET ONLY
(BUT if street lights are on, the Pool is closed.)

Presence inside the Pool fence after hours is **trespassing**

14. **No food or beverage (other than water in a plastic container) is allowed in or within 3 feet of the pool.**
15. **No pets or firearms** or other weapons **anywhere** on Facility property.
16. **No running anywhere inside the pool area.** Anyone running WILL BE asked to leave the pool area.
17. **No person having any of the symptoms of any communicable disease may enter upon the Facility property.** Any person exhibiting symptoms of a communicable disease may be asked by Facility staff to leave the Facility. Refusal to leave the Facility when requested by a Facility staff person will result in immediate and permanent termination of the refusing person's household's privilege to be on the Facility Property. No member has authority to request any other person to leave the Facility.
18. No person with open wounds, sores, skin infections, bandages, or band-aids is permitted inside the pool fence, fitness room, or playground fence.
19. No profanity or other behavior that is offensive or inappropriate in the presence of children.
20. No audible or amplified music. All audio and video entertainment must be played through personal listening devices (ear phones, headphones, and the like).
21. Everyone must leave the fenced-in pool area when thunder has been heard at the pool and must remain outside the pool area for 30 minutes afterward.
22. Securely close the entrance gate after passing through it. The gate never may be left open. Do not allow the pool gate to slam closed. **Do not allow any person not in your group to enter through the gate behind you, and do not open the gate for anyone.**
23. All persons entering the pool must wear a swimsuit. No "cut-off" shorts are permitted in the pool.
24. Everyone must place their trash in the appropriate trash containers.
25. No bicycles, skates, heelys, skateboards, or scooters are allowed on Facility property.
26. No "oversized" water toys or floats. "Oversized" means larger than for one person.
27. All children wearing a diaper of any type are required to wear plastic swim pants over their diaper or swim diaper while inside the fenced pool area. Any member who causes or allows the presence of feces in the pool area will be suspended or terminated at discretion of the Facility and will pay all costs incurred by the Facility to sanitize the pool or surrounding area.
28. No cooking or food preparation of any kind inside the pool area, except underneath the Pavilion, using the grills provided by the Facility.
29. No chairs, lounges, tables, or umbrellas, except portable folding camping chairs in the pool area, except those provided by the Facility.
30. **No smoking or vaping anywhere** on Facility property.
31. No person using or under the influence of alcohol (above the legal limit for driving a car) or drugs is allowed on Facility property. Illegal conduct will be reported to the Sheriff. Intoxication (above the legal limit for driving a car) is a violation of these Rules and WILL result in termination of membership.
32. No diving, flips, or other tricks or acrobatics.
33. The pool phone should only be used for emergencies. The pool phone number is **(919) 671-2405**.
34. Please shower before entering the pool.
35. Parking on the Facility property is for members and their registered guests only. Overnight parking is not permitted. Vehicles violating the parking rules will be towed or disabled. The fee for removing a disabling device **starts at \$500** and removal will occur only at the convenience of the Facility staff.
36. These rules may change at any time without notice.
37. Please report any violation of these rules to Facility staff or using our website.
38. Violation of these Rules will result in suspension or termination of a member's membership in the sole discretion of the Facility.
